VII SALÓN FOTOGRAFICO DIGITAL “ILLA DE MENORCA” 2019

SECTIONS:

- A. Free, color.
- B. Free, monochrome, according to definition FIAP.
- C. Travel, according to definition FIAP.

RULES:

1. Participation will be made, exclusively, in digital format and through the website: <https://www.concursosdigitales.com>
2. On the same website you must fill out the registration form, following the instructions indicated.
3. A maximum of four (4) images can be presented in each section. You can't submit the same image in more than one section, if you do, the jury won't score any of the duplicate works.
4. Images must be uploaded on the website in JPG format. The maximum dimension will be 1920 pixels in horizontal and 1080 pixels in vertical, with a resolution of 72 ppi. Each file will have a maximum weight of 1 MB. Images will be projected using a HD projector on a 3x2 ceiling lamp and also on a 32" HD monitor.
5. The Price of registration fees will be a single Price of 20'00 EUR for each competitor, regardless of the number of sections in which participates.

Members of Fotoclub Cercle Artístic of Ciutadella can benefit from a discount of 25 %, so the registration fee for these authors will be 15'00 EUR. This condition must be notified by e-mail to salonillademenorca@gmail.com

Participants who prove to be less than 21 years old, the registration fee will be 15'00 EUR. The participant will be considered to be less than 21 years old provided that he/she complies during the year 2019. This condition must be notified by e-mail to salonillademenorca@gmail.com,

providing official identification document, in pdf format, where the name and date of birth appear.

For registrations of a group of 10 or more photographers belonging to the same photoclub, a discount of 10% will be applied for each participant, for which registration fees will be 18'00 EUR. This condition must be notified by e-mail to salonillademenorca@gmail.com, providing a complete list with the name of all the authors.

6. Payment of registration fees will be made exclusively by PayPal in the account fccartistic@gmail.com, once you fill in the registration form and upload the photographs. Registered participations that have not made the payment after the registration deadline will be excluded from the contest.
7. The SALÓN FOTOGRÁFICO DIGITAL “ILLA DE MENORCA” 2019 is open to the participation of all photographers, amateurs and professionals, from all over the world except for people related to the organization and/or the jury. Any participation could be rejected if any sponsor or organizer reasonably considers that the participation does not conform to the rules and conditions of the contest.
8. Accepted images in the VII SALÓN FOTOGRÁFICO DIGITAL “ILLA DE MENORCA” 2019 will score for the FIAP and CEF recognitions.
9. Participants will receive an e-mail with a link to download the catalog in digital format, on the date indicated in the calendar.
10. The fact of participating implies that the authors authorize the reproduction of their works in order to disseminate the SALÓN FOTOGRÁFICO DIGITAL “ILLA DE MENORCA” and photography in general without limitations of systems, media and countries and without paying any amount in concept of author's rights. This may include the low resolution for publication on a web page
11. Participants are fully responsible for the rights of third parties and for any claim of image rights of their images.
12. **FIAP requeriment:** “With the sole act of submitting his/her images or files to a salon under FIAP Patronage, the entrant accepts without

exception and with no objection that the submitted images can be investigated by FIAP to establish if these obey to FIAP regulations and definitions even if the entrant is not a member of FIAP; that FIAP will use any means at its disposal for this undertaking; that any refusal to cooperate with FIAP or any refusal to submit the original files as captured by the camera, or failure to provide sufficient evidence, will be sanctioned by FIAP and that in case of sanctions following the non compliance with FIAP regulations, the name of the entrant will be released in any form useful to inform the breaches of the rules. It is recommended to leave the EXIF data in the submitted files intact in order to ease eventual investigations”.

13. The four images of a participant will be distributed randomly, in four batches, in each section. The Jury's decisions are unappealable.

14. The fact of participating in the SALÓN FOTOGRAFICO DIGITAL “ILLA DE MENORCA” 2019 supposes the total acceptance of the present bases and, in particular, of the regulation of the FIAP and of the CEF. This acceptance will be explicitly stated in the participation form of the contest.

1 Medal to the best autor of the salón, under 21 years old.

1 Special trophy to the best menorquín author.

DEFINITIONS:

Monochrome: An image is considered to be Monochrome only if it gives the impression of having no color (i.e. contains only shades of grey which can include pure black and pure white) OR it gives the impression of being a greyscale image that has been toned in one color across the entire image. (For example by Sepia, red, gold, etc.) A greyscale or multi-colored image modified or giving the impression of having been modified by partial toning, multi-toning or by the inclusion of spot coloring does not meet the definition of monochrome and shall be classified as a Color Work.

Photo Travel: A Photo Travel image expresses the characteristic features or culture of a land as they are found naturally. There are no geographic limitations. Images from events or activities arranged specifically for photography, or of subjects directed or hired for photography are not appropriate. Close up pictures of people or objects must include features that provide information about the environment. Techniques that add, relocate, replace or remove any element of the original image, except by cropping, are not permitted. The only allowable adjustments are removal of dust or digital noise, restoration of the appearance of the original scene, and complete conversion to greyscale monochrome. Other derivations, including infrared, are not permitted. All allowed adjustments must appear natural.
